



2009 Southern California Regional Championship Information (Region Twenty)

ELIGIBILITY:

All competitors must be currently registered with the World Tang Soo Do Association for 2009. Competition is hosted by Region #20 but is open to members from all regions. All ages and ranks from 10th gup to 3rd Dan are eligible to compete. Only the students of studios registered in Region #20 are eligible for the Region #20 Cups. Regional cups will be given for Male and Female Adult Black Belt, Senior Male and Female Black Belt, and Youth Male and Female Black Belt; division cups will also be given for male and female gup youth divisions and male and female gup adult divisions. Grand Champions are chosen by total points accumulated; 1st place - 10 points; 2nd place - 8 points; 3rd place - 5 points.

- 2: Turn RIGHT onto N HARBOR DR.
- 3: Turn SLIGHT RIGHT onto NIMITZ BLVD.
- 4: Turn RIGHT to stay on NIMITZ BLVD.
- 5: Turn RIGHT onto CHATSWORTH BLVD.
- 6: 2335 CHATSWORTH BLVD is on the RIGHT.
